- I agree to provide a CPP representative access to all parts of my home and property for a home inspection before my application to foster is approved.
- I understand that I may be required to provide foster care to my foster animal for an extended and indefinite period of time.
- I agree that I am over 21 years of age.
- I understand that CPP provides no guarantee as to the health of my foster animal and that my foster animal may have medical needs, socialization problems, and may not be housebroken.
- I agree to provide my foster animal with veterinary care as authorized by CPP. I will not arrange or pay for any elective veterinary care for my foster animal without the express consent of an authorized CPP representative.
- I will take all necessary precautions to prevent my foster animal from either impregnating another animal or becoming impregnated. In the event that happens, I will notify CPP immediately.
- I understand that I may only have my foster animal temporarily.
- I agree that I am fostering this animal for CPP, and that I do not have any right of ownership over my foster animal. I further agree that CPP rights in and to my foster animal are superior to mine. I also agree to provide a CPP representative access to my home and property to check on my foster animal, at any time that I am in possession of my foster animal.
- I agree to immediately return any foster animal in my care to CPP. at the request of its authorized representative at any time and for any reason. If CPP is forced to undertake legal action to enforce this provision of the agreement, I agree to indemnify CPP for all court costs and attorneys fees connected with such an action.
- If I am planning to move at any time during the period when I am housing a foster animal, I agreeto contact CPP prior to my move and provide CPP with my new contact information. I understand that CPP has the right to request return of my foster animal based on my change of residence, and agree that I will surrender my foster animal to CPP immediately upon request.

- I understand that as long as I provide foster care to my foster animal to CPP's satisfaction, I will be given the first right of adoption of my foster animal, at such time as CPP decides to place my foster animal for adoption.
- If at any point I can no longer, or do not want to continue to, provide care and shelter for my foster animal, I agree to contact CPP and arrange for surrender and return of my foster animal back to CPP.
- I will not transfer possession or custody of my foster animal to any other person at any time, except for temporary, short-term possession for the purpose of vet care, grooming, etc.
- I agree to contact CPP with any and all questions or concerns about my foster animal or the Foster Care Program as well as with updated contact information.
- I agree that if I refuse or fail to comply with any provision of this agreement, CPP has the right to terminated this agreement and also has the right to the immediate surrender and return of my foster animal(s). I further consent to provide CPP access to my premises if necessary to facilitate the return.
- I agree that the opportunity given to me to help rehabilitate my foster animal, as well as the chance of a potential future adoption, is of significant benefit to me, and serves as proper legal consideration in exchange for my agreement to the terms of this contract.
- In Consideration of being permitted to foster an animal from CPP, each of the undersigned, for himself/herself, his personal representative, heirs, next of kin, invitees, and/or guests:
- 1. Acknowledges, agrees, and represents that he/she is aware of and assumes the many risks associated with being around animals, including but not limited to the risks of being bitten scratched, jumped upon, knocked over, chased, tripped, infected with a disease, or otherwise injured or frightened, as well as the risks of damage to personal property and that CPP cannot guarantee me or anyone else what type of temperament the animal(s) I am fostering may have, and that I am not an agent of CPP
- 2. Hereby releases, waives, discharges, and covenants not to sue Charlyne's Pound Puppies, its volunteers, agents, members, directors, officers, or any affiliated entities thereof, from all liability to the undersigned, his personal representative, assigns, heirs, next of kin, guests, and/or invitees for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned or anyone else arising out of or related to the fostering of an animal from Charlyne's Pound Puppies.
- 3. Hereby agrees to indemnify and save and hold harmless Charlyne's Pound Puppies, its volunteers, agents, members, directors, officers, or any affiliated entities thereof, from any loss, liability, damage, or cost including bodily injury or property damage arising out of or related to the fostering of an animal from Charlyne's Pound Puppies.
- 4. Hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the fostering of an animal from Charlyne's Pound Puppies.
- 5. Hereby agrees that this release and waiver of liability, assumption of risk and indemnity agreement extends to all acts of negligence by Charlyne's Pound Puppies, its volunteers, agents, members, directors, officers, or any affiliated entities thereof, and is intended to be as broad and inclusive as is permitted by the laws of Texas and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
